CERTIFICATE OF REGISTRATION

The Certificate of Registration is awarded to “Ritham Special School for the Intellectually Disabled Children”, located at No.272, 272/A, Vasanth Nagar, Shenpagathoppu road, Thendral Nagar, Sammanthapuram village, Rajapalayam Taluk, Virudhunagar - 626117, as an Institution for the persons with disabilities vide **Reg.No.236/2025**, under section 51 (2) of the RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016 (Central Act 49 of 2016) to run as a **special school for persons with disabilities (ID, Autism) for Pre-Primary, Primary, Secondary and Pre-Vocational classes**. This certificate of registration is valid from **01.11.2025 to 31.10.2028** and is subject to the following conditions:-

1. The Management should run the institution in accordance with Rights of Persons with Disabilities Act, 2016
2. Application for granting renewal of a certificate of registration should be submitted to this office two months in advance before the expiry of the period of validity.
3. The special school has **60 Male and 25 female** students only at present. Based on the infrastructure the capacity of the institution is fixed at 150 students with disabilities.
4. This certificate should be displayed by the institution in a conspicuous place.
5. The following words may be mentioned in the name board of the Institution to “**Ritham Special School for the Intellectually Disabled Children**”, located at **No.272, 272/A, Vasanth Nagar, Shenpagathoppu road, Thendral Nagar, Sammanthapuram village, Rajapalayam Taluk, Virudhunagar - 626117**, is registered under Section 51(2) of the Rights of Persons with Disabilities Act, 2016.
6. i) Structural Soundness Certificate issued by a registered Engineer under sub-section 4 of section 4 of the Tamil Nadu Public Buildings Licensing Act, 1965 (Act XIII of 1965) – valid up to **31.10.2028**.

ii) License issued by the competent authority under sub-section (1) of section 6 of the Tamil Nadu Public Buildings Licensing Act, 1965 (Act XIII of 1965) – valid up to **31.10.2028**.

iii) No Objection Certificate from Fire Service Department – valid up to **07.09.2026**.

iv) Sanitary Certificate issued under the Tamil Nadu Public Health Act, 1939 – valid up to **24.08.2026**.

7. The registration certificate is valid for the period mentioned therein and is subject to the condition that the certificates mentioned in 7 (i) to (iv) above are to be renewed in time before the date of expiry and a copy has to be furnished to the District Differently Abled Welfare Officer of concerned District, failing which the validity of registration made by this office is deemed to be cancelled from the date of lapse of validity of any of the certificate in para 7.
8. The Institution is subject to inspection by the inspection authorities under the Act/Rules and by the persons / officers authorized by the State Government.
9. The certificate of registration is liable to be revoked as per the provisions given in the section 52 of the Rights of Persons with Disabilities Act, 2016.
10. The registration shall be subjected to the conditions laid down in the **RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016** and the rules and order made by the competent authorities.
